Dear Exhibitor,

We invite you to participate as a resource fair exhibitor in the 20th Annual **Shoulder to Shoulder (StS) Conference**, to be held **Monday, October 29, 2018** at the Red Lion Hotel on the River in Portland. We expect approximately 700 attendees from around the state including: foster and adoptive parents, CASAs, caseworkers, social workers, lawyers, judicial officers, citizen review board members (CRB), mental health professionals, medical professionals, and others who impact the lives of foster and adopted children. We hope you will join us as an exhibitor at the Conference.

To maximize conference participant engagement with exhibitors, we will be including a PowerPoint slideshow of each exhibitor on the main conference stage and will also provide an exhibitor table engagement passport to attendees to promote traffic to tables for a grand raffle prize. Conference participants who turn in passports will additionally be entered into a drawing for a free scholarship for next year's conference.

The Conference exhibitor fee per table is **\$75 for 1 table host and \$100 for 2 table hosts** (an additional \$25 to cover the extra meal). Please note that the exhibitor fee does include a continental breakfast and lunch for 1-2 staff. Electricity can be provided at no additional cost as well.

3. You will see specific exhibitor table tickets at the bottom of the list. Select whether you want 1 or 2 people to host the table (max 2). *Any additional staff will need to register and pay for the conference. To reserve a table – please **ONLY** select a ticket with Exhibitor Table in the title.*

After registering as an exhibitor, you will receive an email confirmation with all applicable conference information. On the morning of the event, please have exhibitor tables set up by 7:30am. Registration for conference participants will begin at 7:30am. Exhibitors may take down their table any time after 2pm.

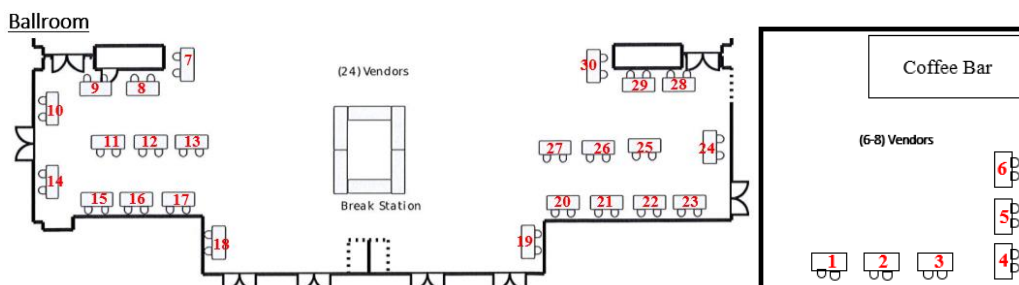
